- a. Set FY 23 Mill Rate
 - The budget was voted down (257 votes yes to 335 votes no) and a mill rate cannot be determined at this time. The Board of Finance agreed that they should meet next Monday, May 16, 2022 at 7 pm to begin work on new budget amount.
 - ii. Dave Fortin made a *Motion to hold a special meeting of the Board of Finance on Monday, May 16, 2022 at 7 pm. *Seconded by Fred Chmura. *The motion passed unanimously.
- b. Approve Increase in TVCCA Program (Meals on Wheels)
 - There was an increase in labor costs at TVCCA as of October 1, 2021 resulting in average bill of 1714.87 per month creating an estimated overage in expenditure of TVCCA line item of \$1808.79 for the current budget. Fred Chmura suggested allowing expenditure of up to \$2000 for the TVCCA line item in current budget and decide where to use surplus funding to cover additional cost at a later time.
 - Fred Chmura made a *Motion that the TCCA line item may be exceeded by not more than \$2000 for the current budget. *Seconded by Michael Dougherty. *The motion passed unanimously.
