- b. Discussion of Additional Appropriation for BOE
  - i. Janice Thurlow explained that due to an unanticipated bus run to the Eastconn program that has relocated to Willimantic this year, the district has a potential budget shortfall of \$66,193 for the contracted service of the bus and driver and a fuel shortfall of \$33,086. She explained that the school district is working to lessen the shortfall but may need an additional appropriation from the Board of Finance.

The members of the Board of Finance directed the School District to continue their efforts to lessen the potential shortfall using all means possible and they would place this item on the agenda for their June 13<sup>th</sup> regular board meeting.
