- 4. Approve Minutes from March 3, 2020 Regular Meeting:

 - **A. Update on State Budget**: There were no updates on this item.
 - **B. Update on Local Bridge Project:** First Selectman Swan mentioned his recent conversation with Representative Pat Boyd, who stated he was cautiously optimistic about local towns and municipalities receiving this funding.
 - C. Follow-up on BOE Budget Presentation: None.

7. New Business:

A. General Government FY 21 Budget Presentation: First Selectman Jay Swan presented the proposed FY 20-21 General Government Budget, which totals \$5,490,440 and represents a 2.15% increase or \$115,524 over the FY 19-20 budget. Mr. Swan highlighted overall significant increases and decreases within the budget, some of which included adjusting staff hours in certain departments to provide office coverage during normal business hours, contractual obligations, public safety and highway. Ms. Fitzpatrick clarified that Town Hall hours of operation will not change. Questions from the Board of Finance relating to insurance/benefits and hauling fees were addressed. Chairman Dougherty thanked Mr. Swan for his presentation.

B. General Government Five-Year Capital Plan Presentation: Mr. Swan presented the Five-Year Capital Plan—FY 2021-2025. The Plan is intended to anticipate the future needs of the town and serves as a guide when prioritizing future projects.

Discussion followed regarding fire protection equipment, container roofs at the Transfer Station, local bridges, website maintenance, and the Crystal Pond Park Trout Pond dam. To her knowledge, Ms. Fitzpatrick stated the container roof project has not been done, but John Navarro would be able to speak more on this item. Regarding the dam at the trout pond, First Selectman Swan reported that the towns of Woodstock and Eastford would be required to have engineering plans drawn, pre-approved by the DEEP, indicating their course of action for the dam—either repair or removal. This item is ongoing with no course of action determined at this time. Relative to the bridge projects, until confirmation is received relative to the STEEP grant, bridge projects are on hold. The town continues to be in communication with CHA on this item.

Ms. Fitzpatrick noted two pending union negotiations, which could change some of the proposed figures within certain departments. These were footnoted within the proposed budget.

C. Warn a Public Hearing: Chairman Dougherty noted the following for the record:
