- **4.** Regular monthly meeting minutes of February 13, 2018: Motion to approve M. Bernardi/R. Bradrick. D. Richardson pointed out 1 sentence which should be modified.

Page 4, last paragraph; delete text \$300,000 and replace with "\$200 per student discount...." M. Dougherty pointed out Page 4, #C, Quarterly Reports: fourth paragraph delete "Entitlement" and replace with LoCIP. Page 4, sixth paragraph; replace 0.77% with 0.97%.

Motion to approve as amended passed unanimously.

- **6.Public Comment:**

Greg Kline noted, regarding the letter he sent, that the correction in the minutes as stated by Richardson was correct and the NFA discount is \$200 per student to the City of Norwich, this data directly from their website. Chairman Dougherty noted the request for information discussed at the last meeting has been submitted.

7.Unfinished Business

- **A. Update on State Budget:** No new information has been received.
- **B.** Review Fund Balance Policy: M. Dougherty noted that there is a great deal of uncertainty. Motion R. Bradrick /M. Bernardi to continue the suspension of the cap on the unassigned fund balance, as was done last month, passed unanimously.
- c. **Discuss CNR Status:** The Chair M. Doughty reported that the Town Meeting on February 28 approved the recommended CNR transfers for Town Hall improvements: \$163,727
- **D. BoE Update:** No questions or comments on the reports. M. Doughty asked Superintendent V. Toth if there was an update on the shortfall in the project budget for this year; he stated that there are no updates are this time.

8. New Business

- A. Letter from Open Space Land Acquisition and Farmland Preservation Committee: D. Adiletta reviewed details of possible future acquisitions through the Open Space Land Acquisition and Farmland Preservation program. She seeks to keep the Board of Finance updated as to the funding status of the Open Space account: 25% of comes from the town, the balance from state or federal sources. These amounts budgeted by Woodstock would not normally be exceeded. The amount asked for continuing contributions is \$25,000. The budget request is not an increase but is in a different format than previously. There has been a reduction in the line item for costs as the state handles this differently now. The current year's line item will probably be not completely expended. 5 applications are currently pending.
- B. BOE FY 18-19 Budget Presentation by Superintendent of School V. Toth(Budget copies are available to the public)includes the highlights and statistics behind the FY18-19 Budget request by the Board of Education, which proposes a 5.68% overall increase (due primarily to

contractual and Academy cost increases with a re-allocation of Special Education amounts)
