- 1. Call to order: First Selectman Jay Swan called meeting to order at 7:00 pm

### 2. Approval of Minutes of October 7, 2021 Regular Board of Selectmen Meeting

a. Chandler Paquette made a **Motion** to approve the Minutes from of October 7, 2021 regular Board of Selectmen Meeting as presented. **Seconded** by Greg Kline as written. **Motion Passed Unanimously.**

  - ii. Since the meeting, more than a dozen additional suggestions via email have been received by the Town of Woodstock on the ARPA email account (arpa2021@woodstockct.gov)
  - iii. Reminder: The Board of Selectmen meeting on the 3<sup>rd</sup> Thursday of each month will continue to be held via Zoom in order to increase participation and transparency while determining how to use the ARPA funds.
- b. Finance Director, Karen Fitzpatrick reviewed the ARPA plan. The updated ARPA overview details can be found on the Town Website ( <u>ARPA Overview 10.12.21</u> document). The preliminary plan for funds was presented to the public at the Special Town Meeting on October, 12, 2021 and can also be found on the Town Website –( <u>ARPA Preliminary Ideas for use of Funds</u> document).

### 5. Correspondence and Announcements

- a. Tuesday, November 2, 2021 is Election Day. The polls are open at the Town Hall from 6am to 8pm. In conjunction with TEEG, food and or cash donations are being collected for those in need. This information has been posted on the website and will be sent home via email to all school families.
- b. The speed display signs obtained by the Town of Woodstock have been installed in order to make drivers more aware of their speed in hopes of making town roads safer for the citizens of Woodstock. Special permission will be needed to place these signs on any state roads. Both are currently placed on town roads.
- c. Town of Woodstock has partnered with the Town of Pomfret to host a Household Hazardous Waste Collection Day. Hazardous Waste can be brought to the Pomfret Community School on Saturday, November 20, 2021 between 9am and 1pm for disposal.
- d. TEEG Mobile Market Dates for the Woodstock Town Hall are Tuesday, November 9, 2021 from 10:30 to 11:30 am and Thursday, November 18, 2021 from 1-2 pm.
- e. COVID Update- Woodstock is currently red along with 11 other communities in Windham County.

- h. The BOS is also working on an ordinance to ensure that No Smoking on Town Properties include cannabis use. This ordinance is separate from those that would be decided by the Planning and Zoning Commission after the one year moratorium placed on cannabis use.
- i. Application received for Kathy LaBonte to be appointed to the Recreation Commission. First Selectmen would like to make appointment to the Recreation Commission and needs motion to amend the Agenda to include appointment.
- j. Letter received from the Historic District Commission stating that they accepted the resignation of Karen Olah as an alternate member and voted in favor of appointing her as a full member.

### 6. Consider appointing Kathy LaBonte as member of the Recreation Commission

**Motion** made by Chandler Paquette to appoint Kathy LaBonte as a member of the Recreation Commission. **Seconded** by Greg Kline. **Motion Passed Unanimously.** 

### 7. Consider appointing Karen Olah as a full member of the Historic District Commission

**Motion** made by Greg Kline appointment Karen Olah as member of the Historic District Commission. **Seconded** by Chandler Paquette. **Motion Passed Unanimously.** 

#### 8. Public Comment

- a. Dave Elliot, Emergency Management Director, would like it noted that the current Radio Systems Project is facing a possible price increase of 4.5% and that he would like that considered in the ARPA funds process. It would be in the betterment of the town to move this project forward in terms of finance and supply/demand.
  - i. Board of Finance Chair Michael Dougherty has looked into this concern and feels that it is a relevant reason to consider as the increases could be \$22,000 to \$24,000.
    - 1. This topic has been discussed and the final ruling by the Treasury Dept. will determine how the funds will be spent. It is noted that the savings of \$22,000 to \$24,000 could fund other smaller projects.

### 9. Other From Committee

a. Chandler Paquette wanted it noted to Selectman Kline that the comment he published in the Woodstock Bugle about the Republican majority on the Board doesn't think that public input matters is an untruth/ unfounded.

### 10. Adjournment

 a. Chandler Paquette made a Motion to adjourn. Seconded by Greg Kline. The motion passed unanimously. The meeting adjourned at 7:29 pm.
