# Woodstock Board of Selectmen Minutes

- 1. Call to order: First Selectman Jay Swan called meeting to order at 7:00 pm.
  - a. Present: First Selectman Jay Swan & Selectwoman Kate MacDonald
  - b. **Others Present**: Charlene Perkins Cutler, Ray & Pam Morgan, WVFA Chief Eric Young, Jessica Weaver Boose, Philippa Paquette, Recording Secretary Amy Monahan
  - **c.** Jay Swan made a \*Motion to amend agenda to include request from the Arboretum to be added to the agenda. \*Seconded by Kate McDonald. \*The motion passed unanimously.
  - d. Selectman Chandler Paquette is excused.

### 2. Approval of Minutes

- a. May 4, 2023 Regular Meeting
  - i. Kate McDonald made a \*Motion to approve the Minutes from the May 4, 2023 Board of Selectmen Meeting. \*Seconded by Jay Swan. \*The Motion Passed Unanimously.

#### 3. Public Comments

a. Eric Young is present with requested bid/estimates for ambulance pricing. He noted that actual bids are lasting 30 days and he currently has some general numbers. The bid from last year was \$265,000 and this year is \$321,789 with a decrease in truck size. He noted that 4-wheel drive is required for this area and E-models do not retain trade in value. Eric also noted that delivery times are now running 2 years out. Jay Swan would like Eric to gather some additional information and plan for a special meeting including Karen Fitzpatrick and Chan Paquette in the next few weeks.

### 5. Arboretum

- a. Philippa Paquette had sent a package to the BOS for review. She noted that the summertime results in no volunteers at the Arboretum with students out of school. She is looking to hire 6 hours per week for weeding and gardening tasks. She is requesting permission to hire and advertise the position from the Town. Salaries for the hours would be minimum wage and would come out of Arboretum funding.
  - i. Kate McDonald made a \*Motion to approve request to hire employee(s) for summer maintenance at the Palmer Arboretum as presented. \*Seconded by Jay Swan. \*The motion passed unanimously.
- b. Philippa Paquette shared that the Arboretum has a request to hold a wedding ceremony in the gardens. The request proposes the attendance of 20 people for a wedding ceremony only. There will be no food or reception and they party would take out insurance to cover the event.
  - i. Jay Swan made a \*Motion to approve the use of the Palmer Arboretum for the wedding ceremony as presented. \*Seconded by Kate McDonald. \*The motion passed unanimously.

### 6. Tax Abatement for Qualifying Farms

- a. Jay Swan announced that the FY 23-24 Budget passed at referendum on May 9, 2023 and that the reinstatement of Prop 46 failed (824 in favor and 1108 opposed) with only 29.9% of eligible voters participating at the polls.
