1. Call to Order: First Selectmen Jay Swan called the meeting to order at 4:00pm.

2. Approve the Minutes of the December 17, 2020 Regular Board of Selectmen's Meeting: Selectmen Greg Kline made a motion to approve the December 17, 2020 Regular Meeting Minutes as presented. **Motion passed unanimously.**

3. Consider the Appointment of John Cimochoowski as a Full Member of the Water Pollution Control Authority for the Term of January 21, 2021 through June 19, 2023: Selectmen Chandler Paquette made a motion to approve the appointment of John Cimochoowski as a Full Member of the Water Pollution Control Authority for the Term of January 21, 2021 through June 19, 2023. **Motion passed unanimously.**

4. 6. Tax Rebates: Mr. Paquette made a motion to approve the following Tax Rebates:

- A Tax Rebate in the amount of \$1995.53 to Meribeth and Michael Tedisky as an adjustment for previous owner paying real estate taxes before the closing; new owner is responsible.

Motion passed unanimously.

7. Correspondence and Announcements: Mr. Swan received a thank you note from the Trustees of Roseland Park for the donation made by the Woodstock Recreation Commission.

8. Public Comments: Mr. Cimochoowski thanked the Board of Selectmen for approving his appointment to the Water Pollution Control Authority. Now that he has retired, he is looking forward to becoming involved in Woodstock once again.

9. Other from Committee: Mr. Kline stated that he has discussed with Recreation Director Anthony Pezzetti that in the future families who enter the Christmas Decoration Contest should be disqualified if their house numbers are not clearly visible.
