1. Recreation Director Report

Director Pezzetti provided an update on the status of current programs, upcoming programs, past events, and possible future programs to members of the Woodstock Recreation Commission (WRC).

Current Programs:

The Director will explore costs and the committee will discuss developing a policy going forward.

Take down will occur after the tree lighting at 4:30P.
