Just an FYI, the law was changed this year as to the timing of the requirements. I heard the discussion at the end of the last meeting. See attached. It still requires the 4 hours during calendar year 2023 for anyone who was in office on 1/1/2023, but it gives anyone who was sworn in after that date a year to satisfy the requirements. So the people elected in November have until November 2024 to get their hours in. It also changes it from a requirement that people get retrained every other year to every four years or, if like Woodstock you have six year terms, during that term because it is longer than four years. I would also assume that they can accumulate hours, rather than wait 5 or 6 years to take them all.

The PZC still has to report to the Board of Selectmen by 3/1/2024 whether or not they have complied under CGS 8-4c(c):

(c) Not later than March 1, 2024, and annually thereafter, the planning commission, zoning commission, combined planning and zoning commission and zoning board of appeals, as applicable, in each municipality shall submit a statement to such municipality's legislative body or, in a municipality where the legislative body is a town meeting, its board of selectmen, affirming compliance with the training requirement established pursuant to subsection (a) of this section by each member of such commission or board required to complete such training in the calendar year ending the preceding December thirty-first.
